3. **Layaway Period:** Layaway Plan Period expires May 1st 2017. Your total Layaway Order must be received and paid in full by May 1st, 2017.
4. **Down Payment:** The minimum down payment of 10% of your total Layaway Order is required with the signing of this Contract.
